Dear ACTRA Arena Operators & Producers,

It has always been ACTRA's goal to provide the best information and services at the lowest cost possible. In order to keep our arena operators/producers protected adequately, we needed to upgrade our policy and with upgrades came a significant expense.

We are confident this is the best roper information and insurance coverage at the lowest cost possible. The new Arena membership cost starting the 2022 roping year is a \$450 fee, plus \$10 per roping day (sent with roping results) for coverage from November 1st through October 31st. A premiere ACTRA membership is included for the named arena operator/producer.

If you have a policy that provides you the same coverage, you can purchase an Arena membership contract for \$150, plus \$10 per roping day (sent with roping results) and provide an insurance certificate listing ACTRA as an additional insured. It must provide the same coverage as provided by ACTRA.

Thank you for all you do to make ACTRA the great association that it is.

ACTRA Arena Operator/Roping Producer Membership Application



This contract for the services of the ACTRA (American Cowboys Team Roping Association), signed This _____ Day of _____, 20____ a legal document providing the agreement of terms and conditions of such services by the Arena Operator/Roping Producer and the ACTRA, each to be legally bound to these terms and conditions. It is also an agreement of the Arena Operator/Roping Producer Membership to the ACTRA.

Contract/Agreement:

1. All point roping(s) will be run according to the rules set forth in the current year's rule book of the Chapter.
2. The Arena Operator/Roping Producer must be a Premier Member of ACTRA.
3. The Arena Operator will hold out the set fees from every roping pot, whether for points or not, which will be sent in with the roping results. The fee is \$1 per team and One Team (\$15/ man roping. Hold out \$30) per roping.
4. The Arena Operator will pay \$10 per roping day, which will be sent in with the roping results.
5. Every Roping results must be sent into the ACTRA (State) Secretary, postmarked **no later** than seven (7) days from the date of roping. (Chapter may assess a fine for each result not postmarked within 7 days)
6. The Arena Operator may have no more than one non ACTRA roping per day unless previously approved by the ACTRA Chapter Board. The point roping(s) must be the first held on that day or at a reasonable hour unless previously approved by the Chapter Board.
7. ACTRA roping memberships are mandatory at all roping(s) and applications will be accepted by the Arena Operator/Roping Producer.
8. The Arena Operator/Roping Producer must provide any and all available previous results upon request.
9. The Arena Operator/Roping Producer must advertise his/her roping(s) in a roping newspaper or flier, ect., a copy of the flier being sent to the Chapter Secretary, member arenas in the chapter and the www.actra.org, must advertise the cattle charge and/ or any other fees in all advertisements. He/She must also incorporate the ACTRA logo in all his/her advertisements and send a copy to the State Secretary and National Secretary if they are not published on the official website www.actra.org.
10. The Arena Operator/Roping Producer has the right to check on any roper's classification/eligibility at any time and can do so by requesting to see the roper's ACTRA membership card, utilizing the online Producer Search, contacting an ACTRA Director, or contacting the State or National Secretary. The Arena Operator/Roping Producer must acquire all necessary information on the roper including name and or names used, address, including state, date of birth, other team roping association classifications, and any other pertinent information that will be forwarded to the Chapter Secretary/Board of Directors.
11. The Arena Operator/Roping Producer who has access to, or is issued/given a list of ACTRA roper's qualifications may use this list for his own roping(s) only and not for any roping(s) not sanctioned by the ACTRA Chapter Board. He/She may not let anyone other than himself/herself use this list for any other reason. He/She also understands that this **list is copyrighted** and therefore any duplication without the written consent of the ACTRA is punishable by law.
12. The association will try to help and work with the Arena Operator/Roping Producer to insure a successful roping.
13. The Arena Operator/Roping Producer will try to work with other ACTRA member arenas in his region on planning roping dates or working through the Chapter Secretary.
14. The arena conditions and cattle used by the Arena Operator/Roping Producer will be kept in the best possible condition, all things considered such as weather, # of teams, etc.
15. The Arena Operator/Roping Producer will always honor the ACTRA ineligible list as posted on www.actra.org or provided by the Chapter or National Secretary. **\$100 Fine will be assessed to any arena that allows an ineligible roper to rope before clearing their fines.** He/She will also have access to use the ineligible list at all times.
